**CIVIL TRIALS, ARGUMENTS, RELATED DEADLINES in 2020**

**MOTIONS:** (See Cra.R.C.P. 208.3(a))

Uncontested Motions shall be filed in the Prothonotary's Office

Contested Motions may be filed in the Prothonotary's Office or in Motions Court held every Monday, Wednesday and Friday (except holidays) at 8:45 am.

**CIVIL TRIALS:** (See Cra.R.C.P. 212.1 and 212.2) After discovery has been completed (following a notice to complete discovery), any party may file a certificate of readiness to have the case listed on a trial term. Trial lists close on the dates indicated below. All plaintiffs shall file pretrial statements within 30 days after the certificate of readiness is filed. All defendants and additional defendants shall file pretrial statements within 45 days after the certificate of readiness is filed. A pretrial conference will be scheduled generally during the first full week of the month prior to the start of the trial term.

**\*\*Inactive cases will be terminated on 06/01/2020 pursuant to Cra.R.C.P. L302.**

**Miscellaneous hearings** and other matters will be scheduled as needed upon motion of a party or as otherwise provided by statute or rule.
